## HEREBY DECIDES AS FOLLOWS:

Article 1: Pursuant to the combined provisions under Article 65 of Law No. 94/01 of 20 January 1994 to lay down Forestry, Wildlife and Fisheries Regulations as well as under Articles 32, 51, 52 and 72 of Decree No.95/531 of 20 August 1955 to lay down terms and conditions for the enforcement of the forestry law respectively, Hunting Area No.9, located in Rey-Bouba Subdivision, Mayo Rey Division, North Region, is with effect from the date of signature of this Decision, suspended for 3 (three) months for non-compliance with the terms of specifications.

## Article 2: This suspension shall entail:

- a stop to activities in the said hunting area;
- a stop to the issuance of documents;

Article 3: The suspension shall be lifted only after the litigation pending against the aforementioned Hunting Area must have been finally settled and regulatory documents to enable its functioning issued.

Article 4: The Director of Wildlife and Protected Areas, the Head of the National Brigade of Forest Control, Regional and Divisional Delegates of Forestry and Wildlife shall, each in their respective spheres, be responsible for the enforcement of this registered and published as and where necessary.
